- ✓ APPARENT AUTHORITY SIGNER MUST PROVIDE DEBTOR WITH COPY OF SIGNED CGA
- ✓ DEBTOR IS PERMITTED TO RETAIN CUSTODY OF THE GOODS.

CONTROLLED GOODS AGREEMENT

KEY POINTS AND CHANGES:

- The new Act replaces "walking possession" with "controlled goods agreements"
 (CG). This ultimately allows the debtor to remain in custody of his goods.
- A CG would state that the enforcement agent is in control of the goods and that the debtor cannot dispose or remove of the goods without the agent's authority.
- In order to re-enter the premises, at least 2 clear days notice of re-entry must be provided
- The notice of re-entry must be given by the enforcement agent.
- Use of force when re-entering the premises is not permitted under the new Act. Permission to use force must be obtained through the court.
- Re-entry must occur between 6am and 9pm. However it is permissible to enter

INTERVENING CLAIMS AND OFFENCES

- ✓ 3rd party claim new procedure: application to court and payment into court
- ✓ Breach procedure- claim damages and/ or return goods (but EA not a trespasser due to any defect warrant)

CRIMINAL LIABILITY

- ✓ If the debtor/third person intentionally obstruct Enforcement Officer/Agent
- ✓ If the debtor/third person intentionally interfere with controlled goods
